- 3) Approved the request from Joel Astleford to sole source a bus wash from TAM Buildings in the amount of \$334,562.

Moved by Shane Drift; seconded by Travis Morrison; to adopt Resolution No. 34-2021, Council needs full council approval for accessing the Fortune Bay Resort Casino Health Account for reasons other than payment of health claims and fees. Carried 4-0-0.

Moved by Shane Drift; seconded by Travis Morrison; to adopt Resolution No. 35-2021, amendments to Resolution No. 63-2020 that the Health & Human Service Board will recruit, evaluate and recommend for the RTC's consideration and final approval those persons the RTC should employ or engage as independent contractors within HHS, and the Board will evaluate the performance of the persons the RTC hires as employers or independent contractors, and the Board shall recommend for the RTC's consideration and final approval the termination of an HHS employment or independent contractor relationship.
