# Morrison opts not to run for re-election

NETT LAKE— When Travis Morrison first took office in 2016, he wanted to be that guy who had what it takes to make a difference.

Morrison was that guy for his first four years as he familiarized himself with issues important to the Bois Forte people and juggled those demands with his family life.

However, growing demands on himself and the rest of the tribal council over the next four years made him realize he had given all that he could.

And hence the reason why Morrison recently decided against seeking a third term as District I Representative.

His decision opened the floodgates for six others to claim his seat. The primary election is slated for April 2nd, and the top two vote-getters will advance to the general election in June.

"We have so many meetings with state agencies, commissions, and other departments," said Morrison. "That's great because it means we are making progress for the band, but it was so time-consuming—it wears on you."

Morrison, who recently attended an employee party at Fortune Bay, said he misses being able to pop in for events like that more frequently. He did so to let the employees know how much he and others on the council appreciate their hard work within a 24/7 business cycle.

"We would still get the invites every once in a while, but we couldn't always go because we were scheduled to be somewhere else," said Morrison. "That was frustrating because we didn't have the time to do what we used to do because our job evolved so much."

As far as offering advice to whoever wins his seat, Morrison said he would tell that person the same thing he told the winners of last year's election.

"I told Robert (Moyer, Jr., District II Representative) and Tara (Geshick, Secretary/Treasurer) to make sure to have some balance in your life," explained Morrison, who is married (Teri) and has four boys, Trevor, Sean, Steve, and Scott. "Don't let this job take everything from you—it can, and will, consume all of your time. You can't overwork yourself, or you will realize you can't have that fun, family-work



balance."

Once Morrison's term ends this coming summer, he plans **See Morrison page 3** 

## Eleven candidates vying for two seats on Tribal Council Chavers faces four challengers; six to contend for Morrison's seat

NETT LAKE—It will be a crowded field for the upcoming Bois Forte Tribal Council elections with a total of 11 candidates vying for two seats.

As of press day, January 30th, the candidates are still uncertified, pending background checks and residency requirements. The eligible candidates are expected to be certified as soon as February 7th and at the latest, February 12th.

Incumbent Cathy Chavers will seek another term as trib-

al chair, but will face four challengers, including former tribal council member Ray Toutloff and Hannah Lehti-Chosa, who narrowly lost out to Robert "Junior" Moyer in last year's race to win the District II seat. The other two candidates for the tribal chair are political newcomers Brian L. Whiteman, Sr. and Carlos Hernandez.

However, if Chavers receives 50 percent plus one additional vote in the primary, there will be no need for the general

election for her seat.

Meanwhile, there are six candidates running for one of the District I seats. The other incumbent Shane Drift is in office until 2026.

The candidates running for the other District I seat are William G. Isham, Perry. L. Drift, Edward Villebrun, Michael L. Connor, David H. Villebrun, Jr. and Robbie E. Goggleye, who previously served as executive director for the Bois Forte Tribal Government.

This seat will be vacated this coming summer when Travis Morrison's term expires. Morrison, who has been in office since 2016, opted not to seek re-election.

It is unknown if and when any candidate debates will be set up, so please look for more information in the March Bois Forte News, KBFT Radio, or the Bois Forte website (www. boisforte.com) and Bois Forte's social media outlets for more

not fall on deaf ears as there are some agencies that are incorporating a grant writer for the tribes to assist us in accessing funding. This is helpful for Bois Forte and very much appreciat-

The Tribal Council and the Directors along with other management are currently working on our strategies plan for the band. We also want to get community input to see what direction our tribal members want us to focus on. We are also including our urban programs in this as well. This is a work in progress, and we hope to move forward as fast as we can on this.

The Tribal Council is working on getting our policies updated and adopted. We just approved our social media policy, which was started in or around 2010. We are also looking at the comments on the Leasing Policy to get that policy finally updated and passed. The staff is working on updating the Bois Forte Personnel policies as well.

Bois Forte is getting closer to choosing a new software program for our accounting department. Our request for proposals has been sent out and our goal is to have this new software implemented in January 2025. The software and training for staff will be done this fall hopefully. We are also trying to incorporate Human Resources software and other programs as well. This will be a huge benefit not only for our programs but also for the people who have accounts in water and sanitation, housing etc.

We know that things do take quite some time to get done but once completed it is worth the wait.

We are also looking into energy funding and food sover-



eignty.

There is quite a bit of funding in these areas that we need to pursue. Chi Miigwech!

# District 1 Representative Shane Drift



Boozho, Bois Forte Band Members! First off, Happy New Year's!

I sincerely hope that this notation finds you and finds you well. I have talked about the following issues on my "Shane Drift District I Representative Updates" group page. When the tribal council met with Secretary of State Steve back. This is time-consuming. Simon on Wednesday, June 14, 2023, I talked about the differences between the state of Minnesota and the MCT/Tribal voting processes.

When the state of Minnesota holds its election, people receive their absentee ballots in the mail. They fill out their absentee ballots and mail them back in. People can also go to their local polling place to vote.

During tribal elections, the candidates must mail out a request card to the band members; the band members must fill out the request cards and mail them back in; once the election board receives the request card, they mail out the absentee ballot. Once the band member receives the absentee ballots, they have to fill it out, get it notarized, and mail it I suggested to the other council members that Bois Forte should bring this up at the next MCT/TEC meeting. The MCT/ TEC should follow the state of Minnesota's lead and just mail out the absentee ballots. This would make the voting process simpler for you, the band members.

The second issue I am going to address is regarding the Minnesota Chippewa Tribe Election Calendar and the Revised Constitution and Bylaws of the Minnesota Chippewa Tribe, Minnesota. Under the MCT Election Calendar 2024 Regular Election, December 27, 2023: Last Day of sitting RTC member to give notice of resignation to file for other RTC office.

Now under the Revised

Constitution and Bylaws of the Minnesota Chippewa Tribe, Minnesota, Article XIII - Rights of Members. It reads, "All members of the Minnesota Chippewa Tribe shall be accorded by the governing body equal rights, equal protection, and equal opportunities to participate in the economic resources and activities of the tribe, and no member shall be denied any of the constitutional rights or guarantees enjoyed by other citizens of the United States, including but not limited to freedom of religion and conscience, freedom of speech. The right to orderly association or assembly, the right to petition for action or to redress grievances, and due process of law.

Now, what I am getting at here is that the Minnesota Chippewa Tribe Election Calendar and the Revised Constitution and Bylaws of the Minnesota Chippewa Tribe clash. I'll take it one step further: the MCT Election Calendar supersedes the MCT constitution. In my humble opinion, a sitting council member who files for another RTC seat should resign their seat after the filing period closes. The way the system is set up is not equal, fair, or right. The MCT Election Calendar should not supersede the MCT Constitution.

Please keep in mind that I am not speaking for the tribal council or individual council members. I am only sharing as the District I Representative. So, until next time, take care and stay safe out there. Mii'iw miigwech!

"He was always someone that I could talk to no matter what the circumstances," said Moyer, Jr. "We also had some great laughs. I wish him well in his future endeavors."

# $Geyer wins {\it prestigious\,Minnesota\,Trucking\,Association\,award}$

WATERVILLE, MN— Willie Nelson's famous hit song "On the Road Again" perfectly sums up the life that Bois Forte Band member Jeff Geyer has lived since hitting the road some 30 years ago as a truck driver.

"When I first started, I wanted to see the country, and I've pretty much done that," said Geyer, who was recently bestowed with a prestigious 2023 Driver of the Year award from the Minnesota Trucking Association. "I used to drive out to New York City, Connecticut, Massachusetts, Florida, pretty much everywhere."

All told, he has logged more than four million miles and has never had an accident. That may be why he not only won the Driver of the Year Award but also won the Driver of the Month award this past May. He chalked it up to luck, meaning he felt the Minnesota Trucking Association threw his name in a hat, and he won, but one of his friends on Facebook would have none of his modesty.

"...I understand your humility and your heart, but please understand that your name wasn't just picked randomly," wrote Sandra Brakstad on KSTP-Channel 5's Facebook page after the popular Twin Cities news station featured Geyer's accomplishments. "You were given this award based upon your experience, safety record, community involvement and overall values!"

And it probably doesn't hurt that Geyer has a heart of gold who would do anything for anybody. He can credit that to his upbringing with his parents, Donald and Christine (Porter) Geyer.

"My dad used to let me drive around with him when I was a kid, and we'd drive around the lakes of Waterville, which is between Faribault and Mankato," said Geyer, a youthful-looking 60-year-old. "That probably got me interested in becoming an over-the-road driver and led me on this path."

While Geyer used to spend countless hours on the road without coming home, he has now settled into a far more manageable workload.

"I have a dedicated run that starts in Eagan, Minnesota, and then I go down to Des Moines, Kansas City, up to Omaha, and then back again," said Geyer,

who works for Manning Transfer out of Blaine, Minnesota. "I am only gone four nights a week and do the route twice. I leave Sunday afternoon and then return home by noon on Thursday."

In his younger years, the longer stays on the road made for some challenging times in his marriage to his wife, Janet. The couple had six children, one of whom died as a one-month infant daughter due to Sudden Infant Death Syndrome (SIDS). That tragedy, however, opened a new avenue for the couple as they started to adopt children.

"There was a relative that kind of needed help, so we took that child, and through the years, we raised 18 to 20 kids," said Janet in a recent phone interview. "We adopted some Native American kids, and our baby is going to be 16 today—we've had her since she was five months old. We just wanted to provide a better life for these kids."

And that's precisely what they did as Janet made sure she got them to and from

every sporting event or other school activity. Jeff was obviously around, but not enough to equally spread out that workload. All was good though, as Janet knew Jeff's job made it possible for them to provide for their kids and the ones they took in.

"We were always on the go," said Janet. "And it was hard at times. Cell phones have made it significantly easier for us to stay in touch when he's gone. When he first started, he had to use pay phones. Some nights, he couldn't even get a chance to call because either the pay phones were broken or 10 guys were standing in line waiting to make a call."

Those nights when Jeff couldn't get through were stressful, but not as stressful as the inclement weather Jeff faced, where he said he had many "white knuckle" winter trips or even spring ones where icy roads made it difficult to keep his rig on the road. He prided himself on always meeting deadlines, even during those treacherous times.

"My husband definitely takes satisfaction in his work," said Janet. "The only time he couldn't make a stop was when his truck broke down. Other than that, he made it through rain, sleet, and snowstorms. They would ask him how he made it as other drivers weren't able to make their deliveries."

For Jeff, the idea of letting his customers nary crossed his mind. His company entrusted him to make the deliveries, so that is what he did.

"I just make sure to keep alert, listen to music, and drink a Monster drink now and then," said Jeff, explaining how he never took the easy route.

While Jeff never sought out the spotlight for his work, the recently aired KSTP-Channel 5 News feature has changed that. He said he is not on Facebook but added that his daughter kept him abreast of all the comments he's received. Old friends are also seeking him out the old-fashioned way, via phone.

"I'm getting a lot of calls from people I have not seen in 20 years," said Jeff with a laugh. "They are saying, 'Hey, I saw you on TV!" "It's nice to hear from them and then my daughter is saying there are a lot of people congratulating me on Facebook, so it's nice to get those compliments."

Jeff will even get more publicity as the award means he'll be on the cover of the Trucking Minnesota magazine, and he's also up for the National Driver of the Year. All of these accolades are not lost on the Geyer's daughter, Amber Scholljegerdes. She recalled as a youngster how her dad would take her out on some trips to see the countryside.

"I've been places that I'd never see had I not been able to experience it with him," wrote Scholljegerdes in an email. "Anywhere from New York City to Naples, Florida. And I think he is incredibly skilled at backing up with a 53-foot trailer and a sleeper semi. He's backed into some pretty tight spaces, sometimes on his first attempt. He makes it look easy."

Scholljegerdes wrote that her dad is very deserving of the award, not just for his driving ability but also for his great attitude, safety-first mindset, and amazing work ethic.



# Mason gives updates on hunting season and partnership with Contented Critters

The Bois Forte Conservation Department would like to wish everyone a Happy New Year.

Deer and moose season ended on December 31st. We did not harvest any moose this year. I will be contacting 1854 very soon to see if there will be a moose survey again this year and to see how the moose herd is doing.

As everyone knows, we had a very poor deer season. We harvested less than 30 deer this year. I know many Band Members hunted hard to the end of the season. We will have to develop a management plan for next year and the future. I made a trip to Upper Wood Duck on January 16th and was disappointed insofar as I saw one deer; there was likewise not many deer track or trails. Normally, there are many deer there

at this time of year. Hopefully, this winter will continue to be an easy one for the deer, without too much weather stress put on them.

I will also mention how nuisance animal/pets calls and issues have been going. The partnership that Bois Forte DNR established with Contented Critters of Ely, MN continues to be a success. Although we still receive a lot of calls about pets running around and pets that are still being abandoned, we are seeing also that many pet owners are taking more responsible care of their pets. We have had fewer instances of abandonment than we saw just two years ago.

I would like to explain how the process works with Contented Critters. If a person wishes to give up their pet, the animal can be brought by the owner to Contented Critters. Contented Critters will charge you an onboarding fee for this. The fee is for a wellness checkup, any necessary medications, and spay/neuter if needed.

If you find an abandoned animal, you may bring it there. Notify Contented Critters where you found the pet, and Contented Critters will contact us in DNR. Almost every pet that has been brought to Contented Critters has been adopted by another family and has a new home. I believe this is working well and is a good model of how these programs should work. It is far better thing to do than asking the Conservation Officer to euthanize these pets. Keep in mind, if you feel the pet is safe to pick up and bring to Contented Critters, please do so. Anyone can bring these pets




to them. However, if the animal appears dangerous or is behaving strangely, please do not directly engage with the animal, or attempt to pick it up.

Please contact either PD or Conservation Department to assist taking the animal. I personally would like to thank everyone in both Vermilion and Nett Lake for the improvements made to this program. In just the last two months, there 17 pets that have found new homes, instead of 17 pets that the Conservation Officers had to kill. This is the right way to do this, and us at the Conservation Department are very grateful for your help.

# Holm gives update on Carbon Banking and Credit program

The Bois Forte Carbon Banking and Credit program is moving forward quite rapidly. As you will recall, the Bois Forte Tribal Council purchased land totaling about 28,000 acres that was previously held by outside entities, but within reservation boundaries. Bois Forte re-acquired this land with technical help from the Conservation Fund, the National Indian Carbon Coalition (NICC) and the Indian Land Tenure Foundation.

After purchase, the Bois Forte Council took steps to enroll the land into a carbon reserve banking program. Bois Forte grows the trees, which capture carbon from the air. The Band identifies how much carbon is available as credits. and then sells carbon credits to industrial producers who emit carbon above federally- allowable levels. When an industry exceeds a certain level of industrial emissions and carbon, they need to offset the extra emissions by paying for equivalent carbon being saved somewhere else. Bois Forte is now a carbon bank where the carbon is saved. The Council has already determined industries to which the Band will and will not sell the Bands carbon credits.

The process to get to the point where we know how much carbon is actually in the "bank" on tribal lands is a little complex. NICC has stayed on as the liaison between the Band and TerraCarbon, the international company that coordinates the field inventory assessments of the forest stands, validates that the fieldwork and statistical design by which the carbon pool is estimated is done correctly, then verifies the available statistical carbon pool available in the bank. This then becomes the basis for issuing credits to industry buyers.

At this point, the on-site field sampling assessments of the tree/carbon stands are complete. TerraCarbon-assigned forestry crews worked with Bois Forte Forestry crews during the month of December to get 50 site plots with controls across the banking acres assessed. Mild weather let us get this step done quickly.

The data is now back in the hands of TerraCarbon analysts who are matching a lot of co-variables collected for the stands with FIA plots, looking at variability around the data sets, and estimating the carbon contained in the various timber pool types in those sampling plots. Then they can extrapolate that up to the entire acreage area to be used for banking purposes. They are also preparing a risk analysis which assesses the project for risk of carbon loss due to internal and external factors. This assessment looks forward from now to 100 years from now. Because this is a long-term project/venture, there are a lot of inherent longterm risks that we can't predict, such as those possibly tied to climate change. If we lose some stands for some reason, we lose the carbon offsets. So we want to set aside a percentage of new available credits (between 1525%, average 12%) as backup reserve so the program can keep running. If some carbon stands suffer some (hopefully temporary) setbacks and carbon holding ability across the acreage is reduced.

When this program goes live with carbon offset sales depends on how fast TerraCarbon assesses the stand data and calculates the carbon availability. There's also a lot of technical detail time still involved in the risk assessment plan setup, but that won't be done until the carbon pool is verified and validated. And there are other associated

management plans, risk assessment questions, and standard legal assessments and documents that the Tribal Council needs to discuss as well. There is already interest being expressed from outside agencies and industries who want to buy Bois Forte carbon credits,

The Tribal Council will be meeting with NICC representatives in the coming weeks for a project update, and the carbon pool assessment is ongoing. To this end, we can report that, at this point in time, the project is moving ahead as planned.


