#### BIG WOODS OFFERS COMPLIMENTARY ROUTES!

NETT LAKE— Aside from its traditional runs, Big Woods Transit also has free complimentary bus rides from Nett Lake to Cook for bingo at the local VFW Club every Thursday. The bus leaves the village at 5 p.m. and returns after bingo.

Big Woods has a route for elders to the Cook Food Shelf on the 2nd Tuesday of the month. The route starts pick up at 11:30 a.m. in the Nett Lake Village.

Big Woods also offers Vermilion elder's shuttle service to the Tower Food Shelf the third Tuesday of the month. The bus does door to door service on this route and the route begins at 2 p.m.

## Band member Retention Committee is off and running

TOWER— The last time an attempt was made to ensure everything possible was being done to hire Bois Forte band members, the goal focused on employment at Fortune Bay Resort Casino and its enterprises.

Those attempts were made in 2021, and a Task Force was established to accomplish the abovementioned goal. However, the Task Force eventually disbanded, and now efforts are being made to not only revamp the measures but to expand the plan to include employees working at the Reservation Tribal Government (RTG).

Currently, Bois Forte band member employment is right around the 25% mark at Fortune Bay, while that percentage is 56% at Bois Forte. Fortune Bay and its enterprises, including the Y Store, C Store, and The Wilderness at Fortune Bay, have 369 employees, 92 of whom are Bois Forte band members. Meanwhile, the RTG has 259 employees, 146 of whom are Bois Forte band members.

"We're taking a collaborative approach by including members from the Tribal Government," explained Fortune Bay's Director of Human Resources Beth Adams. "I think we're inviting the right people to the table who are prepared to have some honest discussion. We've also had greater access to the data we need to measure our efforts this time

will be critical."

The kickoff meeting was held in early March, while the second one took place on March 30th, which was after the *Bois Forte News* deadline.

"We need to make sure to keep the momentum going and make sure you are showing up if you are on the committee," said Fortune Bay's Director of Gaming E.J. Deegan of the recently established Band Member Retention Committee, which is a reboot of the former Task Force. "We need to make sure we set goals and follow through on the goals we set."

Those sitting in on the first meeting included: Adams, CEO/GM Mayan Beltran, District I Rep. Shane Drift, Secretary-Treasurer Tara Geshick, and Bois Forte Human Resources Director Miranda Lilya. Fortune Bay employees included: Deegan, Taneesha Dupree, Bridgette Burr, Alanna Sherman, and Alicia Williamson. Fortune Bay's Wes King and Bois Forte's Barb Brodeen were added to the committee via a request from Drift.

At the March 6th meeting, Adams provided an overview of the inaugural committee set up. She said that it originated as the "Band Member Recruitment and Retention Task Force" in February of 2021 and was disbanded in October of 2021 because attendance had dropped off and they could not get the data needed to establish goals. The SWOT (Strengths, Weaknesses, Opportunities, and Threats) analysis from the former Task Force was shared, as well as a copy of the accomplishments from 2021.

Adams said there was a discussion about the community survey sent out in 2021 for which "Fortune Bay specific" questions were asked to try to gain a better understanding of band members' perceptions of us as an employer. However, those survey results were never received, so it was suggested that 477 Director Vonda Carr conduct another survey to help answer that question.

"We need to start by looking at the data and identifying realistic goals," said Adams. "Once we have goals identified, we plan to come up with strategies to meet those goals."

And again, this would include both Fortune Bay and RTG employees.

Although it has not been discussed yet, Adams said she would be willing to look at providing incentives for band members to begin or renew their careers with Fortune Bay or the RTG.

There was an event that happened within the State of Minnesota, and it was called Sovereignty Day at the State Capitol in St. Paul.

In 2019, Speaker of the House

Melissa Hortman began the first Sovereignty Day with the House of Representatives and all 11 tribal leaders in the state. It was an event that had never been mentioned or accomplished before and was a great success. At this event, the tribes get to educate our legislative leaders on who we are and provide some history teaching regarding all eleven tribes. These are state leaders who make decisions regarding funding within the various departments, laws, or statutes that need to include tribes, etc. While it was just the House of Representatives, it was a start. Then the pandemic came and put a hold on this event from continuing.

On March 13, the Speaker of the

House, Melissa Hortman, hosted another Sovereignty Day at the State Capitol. However, this year's Sovereignty Day also included the Senate leaders and the House of Representatives with all 11 tribal leaders. Each tribal leader spoke of their tribe and reminded the legislators that we are dual citizens of our tribe and state and are not invisible. Our message reminded them of our need to be included and be at the table when decisions are being made that affect tribes. Some statutes include cities, towns, local governments, and counties; however, tribes are not mentioned, therefore, not included in possible funding streams or legislation impacting our tribal members.

In the afternoon, an educational session was done by Professor Tadd Johnson, Bois Forte Band member,

and Rebecca Crooks Stratton, Secretary-Treasurer from Shakopee, on all the tribes in general. Then there were breakout sessions for the following topics: Environment, ICWA, Education, Law Enforcement, Gaming, and others. All breakout sessions were well attended by all. There was much dialogue and questions asked.

It was a historic day for everyone involved. Even though one day really isn't enough, it is a start, and something is better than nothing.

As an added note, the Speaker of the House Hortman and representatives of the house attended Tribal State Relations training as well! This is a 2- and 1/2-day training on Indian Law and history. The first-ever training for the House of Representatives was at Bois Forte with the Tribal State Relations!

## District 1 Representative Shane Drift

Zagaawininiwag Band Members! It has been a while since I submitted an article for the Bois Forte Newspaper. I sincerely hope that this notation finds you well. I have been posting my schedule and providing weekly updates on my "Shane Drift District I Representative Updates" group page on Facebook.

During the 2023 Bois Forte State of Band, I talked about various topics. One topic that I would like to follow up on is the Eveleth gas station. I was on board with the Eveleth gas station because of its first location. The Eveleth gas station location was at the corner

of Highway 53 and Highway 37, by the off-ramp. The feasibility study that was conducted was based on the first location. The map I have included with my column shows a circle with a "1" in the middle, which was the first location. The circle with a "2" in the middle that's the second location. I got the map off the internet.

Well, since the Eveleth gas station location was moved down Highway 37 (please see map). The reason why the gas station location was moved is because the land base was too small. The road that goes by the second location, they may put in a road that goes to Rock Ridge School. I went and looked at Rock Ridge School. It is more convenient to go by the Slumberland furniture store at the north end of Eveleth.

I informed the other council members that I was no longer in support of the Eveleth gas station. I also stated this at the 2023 Bois Forte State of the Band that I am no longer in support of the Eveleth gas station.

I sent the following email to the other council members, executive director, and tribal attorney on Friday, 3/17/2023 4:02 pm.

"Good afternoon! Jeff Holth sent


us (Tribal Council) a copy of the 5 Star Feasibility study Eveleth, MN gas station back on Tuesday, January 10, 2023 4:19 pm. I am resending the 5 Star feasibility Study again for your review.

This feasibility study was based on the first location which was located at Hwy 53 & 37, Eveleth, MN 55734, Longitude: -92.51832, Latitude: 47.46122, Radial Trade Area, 1 mile (Section 3: Site & Market Assessment of the Feasibility Study). In my humble opinion, since the Eveleth Gas station was moved to the second/current location there should be a new feasibility study and our band members should be able to vote on the new location. I know that this is not in the resolution but it's in our band members and tribe's best interest.

If the Council is going to proceed forward with the Eveleth gas station as is all I can do I respect your decision. My stance is still the same, I am against the Eveleth gas."

Furthermore, I sent an email to the other council members on Tuesday, March 21st, asking for another feasibility study on the second location.

Now, should the Eveleth gas start to fail, the tribe cannot, must not use Fortune Bay Resort Casino to keep the Eveleth gas station afloat.



Please keep in mind that I am not speaking for the tribal council or individual council members. I am only speaking for myself. I am keeping you informed as the District I Representative.

# New Big Woods Transportation route being explored

TOWER— While the remote location of Fortune Bay Resort Casino on Lake Vermilion is seen as a big plus when tourists look to book their trip, it's not necessarily a selling point when trying to attract employees.

After all, many employees have to drive to work from all communities across the Iron Range, including Babbitt, Ely, plus the Quad Cities, which include Virginia, Eveleth, Mt. Iron, and Gilbert. This doesn't include those traveling from Nett Lake, Cook, Angora, Buhl, and Hibbing.

"Transportation can be a struggle for employees," said Fortune Bay's Director of Human Resources Beth Adams. "Driving 60-plus miles to and from work every day can be expensive. Not only for fuel but wear and tear on vehicles."

Adams said Fortune Bay still offers a ride-share program where employees with reliable transportation can get paid a stipend for picking up a fellow employee.

"But," Adams stressed, "with our business being 24/7, it's not always easy to match schedules. There are always logistics you have to sort out to make this effective."

That is where a proposed Big Woods Transportation route can be a game changer for those working at Fortune Bay as discussions are now taking place to add a Virginia route to its schedule.

"We're asking managers and directors to weigh in on what shift makes the most sense to reach the most possible employees," explained Adams. "Early indicators have been pointing to adding an afternoon route as that looks to be the greatest need."

That will especially ring true during the upcoming summer months when an uptick in business will be felt.

"We can only do one run," said General Manager Mayan Beltran at a recent meeting regarding Big Woods' capability to add another route. "Nights and weekends will be the greatest need during the summer. But right now, we are trying to figure out a time (for the run). Obviously, it won't fit perfectly, so we'll need to do some critical thinking and problem-solving to make it work."

And that could mean managers and directors having to alter the typical start and end time for the afternoon shift to make this new Big Woods transportation route work. Adams said two options are still on the table, including the traditional 3 p.m. to 11 p.m. shift and a 4 p.m. to midnight shift.

"We also have to take into consideration that some departments work 4, 10-hour shifts," said Adams. "We'll just gather as much information as possible and figure out a schedule to make this new route possible."

Currently, Big Woods Transportation has three routes, seven days a week that bring employees to Fortune Bay from Nett Lake and make stops in Cook and other remote areas on the way to and from the property. The proposed Virginia route would be operated seven days a week, but Big Woods Transit still needs to amp up its staffing to make this route feasible.

There is also a commuter bus that runs from Vermilion with pick-ups in Cook, at the Dam Supper Club just outside Orr, and then to the Nett Lake Village for those who work at the Reservation Tribal Government offices.

"It is just a very short survey," said Adams in her efforts to collect information that would help nail down the new Virginia route. "Feedback would be greatly appreciated because we'd like to see if this new route is feasible."

Beltran concurred.

"We're just trying to lock down a time as adding a route will help us transport employees from that area," said Beltran to those gathered at the meeting. "We understand that this is not going to be a perfect fit for everybody, but please respond as we want to get that route going."

Beltran said that once a timeline is locked in, he will work with Big Woods

Transit to get the route going.

"That will be the next step," said Beltran. "Again, we are doing everything possible to show prospective employees that we offer many benefits, and this can be yet another benefit we offer that separates us from the competition."

at FBRC to enhance our rewards and recognition effort over the past couple of years for all employees," said Adams. "These efforts include the development of the Pathways Program, investing more money for longevity gifts, and acting on the feedback we receive from stay interviews. I'm sure the committee will be looking at things we can do specifically for band members."

During the March 6th meeting, Geshick shared that the Tribal Council is meeting with every department on the government side to hear their ideas and concerns. They also have sent out a QR code to employees to allow them to voice concerns anonymously. It was suggested that FBRC consider doing the same.

While it is still early in the process, Deegan, a Bois Forte band member and longtime employee at

Fortune Bay, is hopeful good things will come from this latest endeavor. She understands the need to fill many positions at both Fortune Bay and the RTG but doesn't want to lose focus on perhaps a bigger goal.

"I think that we sometimes get so bent out of shape on hiring that we aren't really focusing our attention on our current employees and fixing issues those employees have," said Deegan.

However, Adams is fully aware of that concern, and she plans on doing just that.

"Retaining band members has always been a concern and a priority," said Adams. "That is something we'll always keep at the forefront in determining how we can best move forward with this new committee. As mentioned earlier, we've invited the right people to the table to make a difference for us."

# Community meeting slated for Leasing Policy

NETT LAKE— The RTC is currently seeking comments from Bois Forte members and Bois Forte Tribal Government Departments and employees on the attached draft Bois Forte Leasing Policy.

The RTC will also hold a community meeting during the comment period to discuss the draft Leasing Policy and allow Band members to pose questions and offer feedback on the Policy.

The community meeting will take place at Fortune Bay Resort Casino in the Birch room, which is a part of The Woodlands Ballroom, on Wednesday, April 12th at 4 p.m. Coffee, water and pastries will be served.

## Summary of Draft Leasing Policy

The Leasing Policy outlines the Band's policies related to leasing of trust lands. The Policy was developed to:

- 1. Provide clarity as to what the leasing policies are;
- 2. Provide transparency so that leasing policies are applied and enforced consistently;
- 3. Provide structure to leasing processes for the benefit of the Band's Realty Office; and

4. Ensure that the Band's leasing process complies with applicable laws.

The Policy addresses a variety of leasing-related processes, including the lease application process and management of waiting lists, key terms and requirements for residential and recreational leases, processes for obtaining business and agricultural leases and how those leases are defined, obtaining loans for purchase or construction of homes on leased lands, transferring or selling homes on leased lands, enforcement processes in the event

of non-compliance with lease terms, and Zoning Ordinance and land use requirements. Addendums A and B also outline terms that are required for leases under federal regulations.

A clear, fair, and comprehensive Leasing Policy will greatly benefit the Band and its members. The RTC welcomes and appreciates your comments and feedback as it finalizes this important document.

# Q & A with Reid LeBeau from the 2023 Legislative Session

Editor's note: The Bois Forte Band of Chippewa is fortunate to have Lobbyist Reid LeBeau working on its behalf, not only at the 2023 Minnesota State Legislative session— but year-round, to ensure our rights are protected.

Here is a Question and Answer session we recently conducted with LeBeau, who, along with his law firm, is also a staunch supporter of our annual Indian

Summer Classic, which raises money for the Bois Forte Scholarship Fund and our local Boys and Girls Club as well.


Please give us a little background on yourself so our readers get to know vou a little better.

I am a member of the Cheyenne River Sioux Tribe, originally from Pierre, South Dakota. I came to Minnesota for college and law school, and

as an associate for Mark Anderson at the Jacobson law firm. I am married to Leah, who is from St. Cloud, and we have three boys.

Please tell our readers what your job as our lobbyist means for the Bois Forte people.

I am the representative of the Band at the state capitol and to congress. I work with elected officials and their staff on the band's issues. From gambling to specific governmental program funding, we do it all. We also moni-



How long you've been working on behalf of Bois Forte, and what are some of the more significant victories vou've been part of over the years in conjunction with the work you do for us?

On the federal side, I was the lead lobbyist on the Nelson Act. We were able to finally have congress approve the distribution plan for the Nelson Act litigation money. Since then, I have worked on many issues, most recently ensuring that federal COVID funding was able to be flexibly spent by the

On the state side, I was the lead lobbyist in procuring \$1 million in grants from the state of Minnesota to the tribes to help offset the COVID closures. Since I started as a lobbyist,

I started working for the Band in 2011 I have worked to protect tribal gambling and have successfully blocked expansion by outside interests.

ting is one of the biggest issues being now, we have a firm commitment legislators that it will have tribal exclusivity, but there is a long way to go to the end

At this moment, the legislature is compiling its omnibus bills and is scheduled to take an Easter/Passover break next Tuesday. We will break for a week, and when we return, bills will be sent to the floor. Following that, we will be in conference committee for a few weeks until the final passage in the last days of the session.

Native American gaming is constantly being threatened. Is it frustrating to keep having to fight off those challenges?

I don't find it frustrating. It's an honor to be the next person in a long line of people who have fought for Indian tribes and Indian issues. Who we are and what we have, has always been under attack. It's up to us to show vigilance, commitment, and hard work to ensure anything worth having, and protecting, is worth fighting for. It was something my late friend and mentor, Mark Anderson, instilled in me.



#### Bois Forte's Bob Gawboy inducted into North American Indigenous Athletics Hall of Fame



The North American Indigenous Athletics Hall of Fame announced its second class of inductees earlier this

Founded in 2022 by Dan Ninham, Oneida, and his wife Susan, Red Lake Ojibwe; this year's class features more than 75 new athletes, coaches and

teams to receive the honor for their athletic achievements and contributions to their respective sports.

The North American Indigenous Athletics Hall of Fame recently announced its second class inductions.

Robert 'Bob' Gawboy Bois Forte Band of Chippewa Induction Category: Athlete Year Inducted: 2023 D.O.B. June 28, 1932 D.O.D. July 15, 1987

Although the sport of swimming isn't often associated with Native Americans, Robert 'Bob' Gawboy became an aquatic sensation, setting high school and collegiate records, eventually going on to break a world record in 1955.

Bob Gawboy was born on the Vermilion Lake Reservation on June 28, 1932. At the age of 14, his family moved to Ely where he attended Ely High School. Bob joined the swim team because it practiced at noon and he could then take the bus home after school, instead of walking 10 miles.

In 1949, Ely High School won the state championship. Bob placed first in the 100-yard breaststroke. The following year, he broke a state record in the 200yard free, and set national high school records in two IM events. He went on to Purdue, placing first in the 150-yard IM at the East-West collegiate competition. In 1952, at the NCAA Nationals he placed second in the 150-vard IM.

Suffering from coordination problems, and a congenital arterial condition of his left leg, he was forced to stop swimming. After surgery on his leg, he started working out again in February, 1955, at the University of Minnesota, on a scholarship.

Despite the two year hiatus and short time training, Bob shocked the sports world on April 1, 1955 at the AAU Indoor National Championship at Yale, where he swam the 220-yard breaststroke in 2:38.0, cracking the world-re-

The pain in his leg was so severe during the race and the pent-up emotion over two years so great, that, upon winning, he erupted in whoops and hollers that was called war-whoops by the press with celebratory splashing around the pool.

Bob Gawboy passed away on July 15, 1987 from multiple sclerosis, but not before he was inducted into the American Indian Athletic Hall of Fame in Lawrence, Kansas, as the sole swim-

1854 Officer Leo Vidal wants to remind Bois Forte band members to make sure to have your 1854 ID card (or Tribal ID) and netting permit with you when going out this spring.

He also noted that Personal Flotation Devices are required for each person while on the water.

"Mark your buoys legibly so they can be ID'd by Law Enforcement," wrote Vidal in the 1854 newsletter. "Each member can have no more than 200 feet of net per person and know your netting zone boundaries."
