Comment period extended on leasing policy

TOWER— Even though a healthy discussion took place regarding Bois Forte's Land Leasing Policy, tribal leaders agreed to extend the comment period until June.

"It will give us time to do our due diligence," said Bois Forte Tribal Chair Cathy Chavers after getting support from her fellow council members. "We heard a lot of good questions, and it is up to us as tribal leaders to make sure our band members get their questions answered."

The community meeting, which took place in the Birch room at Fortune Bay in mid-April, was sparsely attended as only 25 or so showed up. However, that didn't mean the meeting was not informative as several band members had inquiries that were met with "That's a good question," by either DNR Manager Chris Holm, who ran the meeting, or Jeff Holth, who is one of Bois Forte's tribal attorneys.

"I think the meeting was informational, thought-provoking, and I felt heard," said Deanna Drift after the meeting. "I have some recommendations in some of the language that I hope is incorporated into the policy. My recommendations protect band member interests."

The gist of the meeting was for band members to let their leaders know what they think of a land leasing policy draft, mainly regarding residential and recreational leases. The original comment period was to lapse on April 17, but band members will have nearly two more months to weigh-in. The official day in June has not been set yet.

"This is not final—this is just a start," said Holth to those gathered. "The whole point of this was to get community feedback, and these comments tonight have been super helpful."

Both Holm and Holth agreed that the first draft of the leasing policy was put together with the help of previous wording on policies pertaining to leases.

"We were pulling together old policies, looking at what had been in place and seeing where gaps can be filled," said Holth, who added that the comments heard at the meeting will be incorporated into comments already received. "... The council will look at all of those and decide how to proceed from there."

While there will be a fair amount of wording left in the leasing policy draft, there were some gray areas brought up by band members during the meeting. Among those that generated some discussion was the "Successor of Interest Clause," which relates to what happens to a lease should a band member pass away and their spouse is not Native.

"The clause previously approved by the Tribal Council allows a surviving spouse or domestic partner of a Band

member lessee to reside on the leased premises for the remainder of his or her life, or the remainder of the lease term, whichever is shorter, as long as the person was residing with the Band member lessee at the time of his or her death," said Holth. "One thing to note is that Band members with older leases must request that this clause be added to their lease through a lease modification."

Holth said the amendment to the lease must be approved at the leasing office, and then the Bureau of Indian Affairs (BIA) must approve it as well.

Some attendees also wanted to make sure a certain threshold of leased land does not go to non-Natives as they might not know how Natives honor and respect the land as it pertains to not disturbing artifacts that may be on the land.

There were some questions about why the BIA is involved with the Bois Forte Land Leasing Policy, and Holth explained that BIA leasing regulations apply to on-Reservation trust lands. Even so, Holth explained that Bois Forte has a lot of discretion about the policies it puts into place. That includes setting lease rates, priority lists, and zoning of residential, recreational, business, and agriculture leases.

"BIA defers to the tribe of how it wants to come up with rules of who gets approved and who doesn't get approved," said Holth.

I had the opportunity to attend Governor Walz's State of the State address along with President Johnny Johnson from Prairie Island. The tribes in Minnesota are adamantly and consistently making our voices heard at the state level and as well at the federal level. An example of that is the passage of the new law strengthening the Minnesota Indian Family Preservation Act (MIFPA) in the event the Supreme Court does not rule in Indian Child Welfare Act's (ICWA) favor when they make their determination. The vote at the state legislature had a unanimous decision in the House and the Senate with only one disapproval. This will ensure in Minnesota that the intent of ICWA will be reinforced in state statutes no matter what.

Before the Sah Gii Bah Gah powwow, we have a tentative date set for the dedication of our Community Room at the Tribal Government Building in Nett Lake for the late Gene Goodsky, our former spiritual advisor. The tentative date is Friday, June 2. We are in the planning stages and will get the details to everyone once they are finalized.

The Tribal Council has decided not to garnish per capita checks this year. The economy and high costs are still there, causing hardship for everyone.

The Council will be working with

our programs and accounting department to begin revising and revisiting payback agreements for those band members who owe the government for rent, water and sewer, tribal court fines, etc.

Band members are estimated to owe the government over one million dollars in revenue that has not been collected for many years. Band members need to realize that by not paying, our programs must be supplemented by the Tribal Council to ensure that our programs still provide the necessary services. This has been going on for many, many years. We need to look

at follow-through and enforcement moving forward to resolve this issue. We really cannot continue this way if we want to get new housing and other projects that will be there for our next seven generations.

Have a safe month ahead and don't forget that May is Mental Health Month. If you know of someone who is struggling, reach out to them and let them know you are there for them and that help is available!

We have a few projects coming up in the next three months if the funding is approved and all the contracts are awarded, so keep in touch with me and make sure I have the best contact information for you.

TERO is looking for four new volunteers to sign up for the TERO Commission. This is a four-person commission and includes two alternates, and the Tribal Council must approve all mem-

As it stands now, residential leases run for 25 years and can be renewed for another 25 years, while recreational leases run for 10 years and can be renewed to a maximum of 50 years. However, one lady said she has a document from 1976 indicating her lease is for 100 years.

"And people are calling me a downright liar," said the woman.

During his review of the proposed policy, Holm high-lighted some critical language, including the fact that once the BIA signs off a lease, the lease-holder has two years to build or put up a structure on the land.

Conversely, those who get a recreational lease do not have to have a permanent structure, but it was noted that the lease could not have more than one structure (i.e., trailer) or RV on the site and that the RV must have current licensing in place.

One attendee, Larry "T-John" Connor, was relieved that his "two-year build" clause has not officially started because he has not received his paperwork back from the BIA, which essentially allowed him a one-year reprieve.

"Woo— woo," said Connor after Holm explained the process. "Man, that's a lot of stress relief for me."

Connor was also pleased to learn that as long as he is making progress on his lot, Holm said he probably wouldn't be penalized.

"Now, if the lot sat vacant for two years and nothing was done, then there might be something done," said Holm.

If Connor had his way, he would prefer to move into an elder apartment complex on

Lake Vermilion. However, that is currently not an option.

"At my age, to spend \$250,000 to build a house doesn't make sense, but I want to have my coffee and look at the lake," he said. "So, I might as well spend my \$250,000 instead of giving it to my kids, and then they can have the house and have their coffee when I'm gone."

Others, like Millie Holmes, had questions about how her family could ensure their father's wishes for what happens to the family home were honored. In this case, Holmes stated that her father, who has since passed, and the family agreed to give the house to his son and their brother, Charlie Holmes.

Holth encouraged Millie Holmes to bring the will to the tribal court to request a judgment regarding the ownership of the home. Once the tribal court clarifies ownership through a judgment, the Tribal Council can issue a certificate of title for the home.

"This is just an example," said Holth. "I'm happy to point you in the right direction because I know things can get complicated and never resolved."

Holth said he understands that drafting and subsequently adopting a new Bois Forte Lease Policy won't be easy.

"There are a lot of questions, but answers can get complicated and will be thoroughly thought out before incorporating this into the new leasing policy," said Holth.

One matter that surfaced during the meeting had to be the lack of communication from Bois Forte's Leasing Department, as band member Rocky King stated his questions have gone unanswered since 2019. He approached Holm after the meeting with his list of questions, and he is hopeful they will finally get answered. Those questions included getting a copy of his renewed lease, what happens to the lease when he dies, will his wife have to pay taxes on it, getting water permanently hooked up, right of way, tree removal, and others.

Former Bois Forte Tribal Chairman Gary Donald also had questions about what happens to the lease when the band member dies and if their spouse can stay there.

"What happens if a band member, says, 'Hey, I want that lease' and then kicks that lady and kid right off the reservation?' Is something in there to protect them?" said Donald.

He also rattled off questions concerning the basis of the rough draft and asked if there was any input gathered from older, traditional Indian people to get feedback from them.

"Did you ask them what they think of the leasing program? How it started, when it started, and why it started?" he asked. "Was anybody like them sitting at the table putting this draft together? Because there are a lot of things in there we are discussing that we don't agree with," said Donald.

Donald, who is 90, said he can remember living at Pelican Lake as a four or five-year-old and his family just lived in the woods.

"And then if we wanted to live in another part of the woods, we moved there—no one kicked us off—hell, we didn't have a lease," said Donald. "And today, we're talking, 'Where's your lease?' 'What's happening with the leasing program—who gets a lease, when they get the lease, and what happens if you break the lease?"

Holm told Donald he was glad those questions were brought up as it gave him a better understanding of what his office should be doing moving forward.

"Keep in mind this policy is just basically a first draft," said Holm, who did a fine job juggling his duties of running a PowerPoint presentation and circulating in the room to respond to questions. "It's bits and pieces of old policies and ordinances that we found and put together. It's not the final, end result. It will need to be developed, and, going forward, we will have Elder input from you and others in the community. I think it is a great idea to have you and others involved."

May is Mental Health Awareness Month

Since 1949, Mental Health America and its affiliates across the country have led the observance of May as Mental Health Awareness Month by reaching millions of people through the media, local events, and screenings. It raises awareness of trauma and the impact it can have on the physical, emotional, and mental well-being of children, families, and communities. Cities and businesses across the country hold various events to support mental health and open the lines of communication. Many websites provide ideas for businesses to support their employees during the month of May and beyond.

According to the CDC, suicide rates in our country increased by 36% between 2000-2021. Suicide was responsible for 48,183 deaths in 2021 alone, which is about one death every 11 minutes. We know that many mental health disorders-including depression, bipolar disorder, borderline personality disorder, and PTSD-come with a heightened risk of suicidal

thoughts or attempts. While seeking help for suicidal thoughts or behaviors is critical regardless of the cause, securing a specific diagnosis may help the individual receive treatment-especially ongoing treatment -that is best suited to their mental health needs.

Mental Health America says that up to 60% of people who die by suicide have major depression, and research suggests that the majority of suicides are related to a psychiatric condition. If you or someone you know is depressed, there are effective treatments available. Talking to your doctor is a good first step, and you can also visit the National Alliance on Mental Health Illness to learn more about support groups that you might find helpful.

The Jason Foundation is another valuable resource. JFI is dedicated to the prevention of the "Silent Epidemic" of suicide through educational and awareness programs. On the website, you will learn about warning signs and risk factors associated with people who may be struggling with mental health issues and suicidal ideation.

Medical Assistance, MinnesotaCare and Minnesota Family Planning Program Notice

Rx BIN

During the COVID-19 emergency, the Minnesota Department of Human Services (DHS) put special rules in place to help you keep your health care coverage. Due to a new federal law, we must now resume renewals. As of May 11, 2023, the Covid-19 Pandemic Health Emergency will end.

Regular Medical Assistance, MinnesotaCare and Minnesota Family Planning Program rules will now apply.

Here is what you need to do:

- Report changes to your contact information
 - Has your address, phone number or email address changed recently? If so, please report these to your county or tribal agency to make sure we can reach you.
- Watch for your renewal
 - We must review your eligibility to see if you still qualify for coverage.
- · Save paper proofs
 - We will need proof of income for you and your family members. Please save current paystubs, income tax returns and other documents that show your income to send in with your renewal form.

The MN Dept of Human Services or St. Louis County PHHS will mail a renewal form to you. If you do not get this within the next 6-8 weeks, contact your county or tribal agency. Without your completed renewal form, your Medical Assistance, MNCare or MFP coverage will not continue.

I worked as a carpenter for around three or four years during my leave of absence; I made a lot of new friends and had a blast building all over Minnesota. But it wasn't until I was lead landscaper on a few projects that those jobs made me realize just how much I missed working with turf. I was in between projects at the time when I was asked if there was ever a chance I'd return to the Wilderness to finish what I had started. I decided that it was the best thing to do not only for myself, the staff, and the course but for the tribe as well. I know our customers deserve the best playing conditions, and I'm going to give it to them.

2022 was not a good year for course conditions at The Wilderness. What have you and your team been doing to ensure those conditions improve for the 2023 season?

I don't know how far into detail you want me to get, but we have an invasive weed on our greens called Poa Annua which isn't the hardiest breed of grass when it comes to cold weather.

Poa will check out after 30-45 days under ice, whereas bentgrass can survive nearly triple that time and is a more predictable plant to maintain. Our plan is to over-seed with a newer variety of bentgrass whose dense growing habit will crowd out the poa, all while treating chemically to give it a growth advantage. The greens will be better suited to overwinter once the population of poa subsides; while this may take a few years, the long-term benefits will be worth it. Most of the ice damage we've fallen victim to over the past few seasons can be attributed to poa decline and ice damage. While there's little we can do about winter, having strong turf going into the end of the season will help. We have plans to adjust the heights of the cut, which will help speed up play and grow back the 20,000 square feet of sod nurseries that have been depleted over the last three years, just to name a few things. 

Friendly reminder to adhere to Blight Ordinance

With any luck, by the time the May 2023 Bois Forte News lands in your mailbox, spring will finally stick around so that we can start tackling those home improvement projects, gardening, and just a general cleanup as we prepare for the summer of 2023.

With that in mind, Bois Forte band members are once again reminded to make sure they are aware of the Blight Ordinance passed by the Tribal Council last year. The ordinance was necessary to make sure homeowners or renters took pride in their property.

"The intent wasn't to punish homeowners; rather, it was to have residents be mindful that we want our communities to be clean and ones we can be proud of," said Tribal Chair Cathy Chavers at the time. "That means keeping a clean yard, mowing the grass, and not letting junk accumulate."

Here are some examples of what would be considered a violation of the Blight Ordinance:

· Storing abandoned/junk automobiles; junked/inoperable motorized farm, lawn and garden or recreational equipment and machinery; accumulated trash, rubbish, or refuse; stoves or appliances; furniture; wood or wood remnants; scrap metal or metal remnants; structurally-failed fences; constructed buildings that are structurally compromised, pose a safety hazard

situation, and/or no longer habitable as dwellings or use for any other purpose; toxic or poisonous vegetation such as poison ivy, ragweed; other weed and grasses over six feet in height that pose potential visibility and fire hazard is-

Bois Forte DNR Director Chris Holm touched on the Blight Ordinance during mid-April's community meeting regarding the Bois Forte Land Leasing Policy.

"The blight code is a brandnew ordinance that deals with blight on properties, such as junk cars, homes that are in disrepair, garbage, or anything that is going to create unsafe conditions for residents around you," said Holm.

He told those gathered at the community meeting that Bois Forte's Environmental Services employee carries out the Blight Ordinance.

"If there are any issues, he will visit the home, talk to the owner and ask them to pick up garbage, get junk cars out of the yard, or broken glass, whatever it is, and then give them time to do it," said Holm.

Holm said if the blight is taken care of in a reasonable amount of time, i. e., in two weeks, the Environmental Services employee will issue a violation to have it cleaned up.

"If we have to go in-or the council says we have to go in to pick it up, then a court citation is issued for the cost of what the clean up was to the person to cover our costs," explained Holm.

In addition, to cleanup costs, the penalties for violating the Blight Ordinance can result in a \$500 fine and could include lease termination; disqualification from obtaining real or rental lease property with the Band for up to 10 years. The time period is subject to the extent of blight, costs to remediate the blight incurred by the Band, and safety hazards deemed to be incurred as a result of the blight condition(s).

Holm said that notices for the vet to be scheduled annual Spring Community Cleanup will be posted on the Bois Forte website and in the June issue of the Bois Forte News.

"It was amazing—I could not believe how many people were there," said Trevor Rintala, who attended the benefit with his girlfriend, Liza Root. "The lines were really long getting in too, but that just shows how much the community supports Brandon."

The benefit was organized by Tina Villebrun, who enlisted the help of many others to make sure everything was topnotch as Benner continues to make significant progress on his road to recovery.

In fact, his wife, Nicole, even brought out an iPad to allow Brandon to FaceTime with those gathered so that he could see firsthand just how much he means to everyone.

"I talked to him a little bit, but so many people were trying to say hi that it was hard to hear him," said Rintala, who used to work with Benner for Mike Bass Construction. "He was waving to everyone, and he looked good. It was very encouraging."

For Rintala, he would not have missed the chance to show his support for Benner. He recounted his days working with him in construction and talked about the fun experience.

"His sense of humor is amazing," said Rintala. "It's hard not to like a guy like that. He loved to joke around, but he also knew his audience, so he knew what to say and when to say it. He made the workday

enjoyable."

Brandon's aunt, Dawn Benner, was unable to get to the benefit, but she has been overwhelmed with how much support her nephew continues to receive. Not only through the benefit but also those visiting him in Duluth as he continues to recover.

"I just want to say a big thank you to Tina Villebrun for thinking of this idea and organizing the event," said Dawn Benner. "The Benner family appreciates all those that attended, donated to the raffle, and helped. The kindness will never be forgotten."

Bois Forte Tribal Chair Cathy Chavers said she, too, was overwhelmed with the show of support Benner received.

"It was very heartwarming to see everyone come out to let Brandon know that we're all thinking of him and wishing him well," said Chavers, who also thanked the organizers and the Cook VFW for hosting the benefit. "I heard the food was delicious, and you could

just feel the positive vibes as people gathered to show Brandon how much he means to all of us."

And that sentiment played out repeatedly at the benefit, which Rintala perfectly summarized on how Bois Forte and the entire tight-knit community always comes together.

"It's kind of the way of our people," said Rintala of the Bois Forte Band of Chippewa. "Being wealthy isn't about having a lot; it's about having enough to share with others. If we can help, we're going to help. My message to Brandon is, just focus on taking it one step at a time because he's going to get to where he's going."

And that means making a full recovery so Benner can get back to doing what he loves the most—engaging with people and making a positive difference in the lives of so many.

"We're all thinking of Brandon and his family," said Chavers. "His fighting spirit is an inspiration to all of us."
