## Lake Vermilion Traditional Pow Wow returns



After a one-year absence due to COVID-19, the Lake Vermilion Traditional Pow Wow (LVTPW) will once again take center stage the last weekend in June.

"Many people stated that they are looking forward to going to a pow-wow since it has been so long," said LVTPW Chair Tracey Dagen of the Pow Wow, which takes place near the Bois Forte Tribal Government Office just off Reservation Road. "Numerous people specified that they missed the LVTPW last year and it is one that they won't miss as it is their favorite Pow Wow."

While there is a lot of excitement in the air about the LVTPW, Dagen would like to remind everyone to maintain social distancing and not to let their guards down as we are not out of the woods with this pandemic yet.

"If we have to move the Pow Wow indoors due to inclement weather, we will have to do temperature scans and masks may be required," said Dagen.

Dagen said even though the LVTPW had a late start on the planning of the 2021 event, things are coming right along. She said that LVTPW was the first one on drumphop.com so they received a lot of inquiries from that listing.

"We have done two Indian Taco/Fry Dog fundraisers where we sold LVTPW raffle buttons and handed out LVTPW flyers," explained Dagen, who added that the next

fundraiser is scheduled for June 12th. "Our first Indian Taco Fundraiser for LVTPW was greeted by an enthusiastic crowd of buyers. We sold out twice!!"

This year's LVTPW will feature the Lake Vermilion Singers and the Burntside Lake Singers. The Pow Wow will be emceed by Terry Goodsky, while Darrell Kingbird will be the Spiritual Advisor.

As has been the norm in years past, the Pow Wow grounds will feature a variety of vendors, meaning the smell of freshly made Indian Tacos will fill the air. There will also be clothing wholesalers on hand who will be selling beadwork.

Dagen said there will be a Two-Step Contest with a big, big trophy and a big, big WWF-style Belt going to the winners.

"A new addition will be 'Paint with Nate,' which will be teaching how to paint and learn different painting techniques," said Dagen of the KBFT sponsored event. "As always, Bois Forte Tribal IDs and 1854 Authority IDs will be available."

The Grand Entry is slated for 1 p.m. Saturday and 1 p.m. Sunday. A singles and doubles bean bag tournament is also scheduled to take place Saturday at 12:30 p.m. Sign up is noon.

Like Dagen, Muriel Deegan is extremely thrilled that the LVTPW is back. She said she's excited to reconnect with family and friends who make the annual trek to Lake Vermilion for this special event.

This pandemic still continues, however, we are managing as best as we can as a tribe.

There are many issues out there affecting us all. Here is a brief update:

The U.S. Treasury has now made its decision on how the \$20 Billion for Native American Tribal Governments will be distributed. There will be two payments to tribes and these payments will be based on the following:

1) First payment will be \$1 Billion split equally among the 580 tribes in the country along with 65% of the other \$19 Billion paid to tribes on a pro-rata basis on certified enrollment numbers from the tribes.

2) Second payment will be based on employment numbers for 2019 on the 941 tax form for each quarter submitted in 2019. This will be the remaining 35% of the \$19 Billion.

We do not have any definite dates on these payments to tribes but all tribes were to go to the US Treasury portal to acquire their funding mechanism and Bois Forte has completed theirs. Now we just wait for the payments.

Also, we do have two programs that have been implemented by the American Rescue Plan and one is the ERAP (Emergency Rental Assistance Program) for renters who are having difficulty in paying their rent and/

or utilities. This program is available now. Please contact Ed Villebrun or Beverly Steel at 218-757-3261 on this program. There are others who are trained to assist, our urban offices as an example, Jacque and Wendy. It is an online application and please utilize this program. It is also for landlords to apply.

Also, we have been notified of the Homeowner assistance program. There is a plan that needs to be submitted before we can get his program up and running, but this program will assist homeowners who have mortgages and may need some help with their payment, insurance, etc. Once we have our plan in place we will be getting the information out to our tribal members as soon as possible.

These two programs mentioned are for anyone, not only on the reservation.

We will try our best to get information out to our tribal members on any of the American Rescue Plan funding as it comes along.

- Even after getting the COVID-19 vaccine, you should still wear a well-fitting mask that covers your nose and mouth when around others, stay at least 6 feet away from others, avoid crowds and poorly ventilated spaces, and wash your hands often.

## District 1 Representative Shane Drift

Howah boozhoo Bois Forte Band Members!

I sincerely hope that this brief notation finds you well! For this brief notation, I will be talking about our Anishinaabemowin (Indian language)! My late Grandmother Jessie Drift used to always say that our language is sacred, it's important. Listening to my Aunty Karen Drift and also Gene Goodsky, we need to do all that we can do to hang onto our language and also preserve our language for future generations.

I know that learning the language can be hard, if not difficult, at times to learn especially when one doesn't have someone to talk with. My Aunty Karen always stresses the importance of hearing the language every day and also speaking the language every day, and she's right. We don't have that many fluent speakers left. We can turn this around so that we have more and more fluent speakers amongst our band members. My Aunty Karen teaches the language on Facebook, and so does Gene.

I sincerely believe that we have a good grasp on our culture. One of the teachings that I have learned is that when an elder shares a teaching with me is that I am to give the elder some asemaa (tobacco). The way it was explained to me is that when you give an elder asemaa you are showing respect to the elder for what he/she has shared with you, you are thanking them. I remember my first time when I gave an elder some asemaa I gave him a small pinch. The elder instructed me to give a good pinch full enough to fill a pipe. I thanked the elder for that teaching. As for giving asemaa, I will ask an elder/healer/ spiritual advisor first, if the elder/ healer/spiritual advisor holds his or hand then I will give him/her a good pinch full of tobacco. Some people give the tobacco first then state their

request. Either way works, I respect both ways. Now if someone came and gave me tobacco and stated their request and I wasn't able to fulfill their request I would hand that tobacco to an elder/healer/spiritual advisor who could fulfill their request. Another teaching my Grandmother gave to me was that never to put someone else's teaching down, meaning never to discredit it or belittle it. Respect all teachings.

As your District I Representative I have advocated for our language and culture at various levels. When I was on the school board, I advocated to increase the language and culture class time in our elementary school. We have had a consultation with North Woods and I pushed for the native language class to be offered to our band member students. North Woods has a native language class for grades 10th through 12th grade. When our students graduate from Nett Lake elementary school and go onto North Woods there is a gap in the native language class. Currently, North Woods does not have a native language class from 7th grade through 9th grade.

We met with Governor Walz and Lt. Governor Flanagan on Friday, February 12th, 2021 at 8 a.m. via zoom. I brought up native languages in schools. The need to provide funding for native language classes in the schools and also make it mandatory to fund the native languages like they do for the other languages.

Governor Walz stated that a chairman (I cannot recall which one) from one of the southern tribes also made a statement about mandatory funding for native language classes. I will continue to push for mandatory funding for native language classes in the schools.

The tribe received a language grant from MIAC (Minnesota Indian

Affairs Council). I am very grateful for this grant. We have been meeting about the grant and what can we do with it. I suggested that we use the grant to create a Bois Forte language book and CD like the Ojibwemowin Series 1 and 2 books. The Ojibwemowin books are awesome! When I worked at KBFT 89.9 FM Bois Forte Tribal Community radio we had word of the day and phrase of day in the anishinaabemowin. I must mention that KBFT 89.9 FM still does the word of the day and phrase of the day in the anishinaabemowin.

Before I wrap this brief notation up, I would like to share a humorous story with you regarding my two kids. When my daughter was in first grade and my son was in Headstart I would teach them words in the anishinaabemowin. We were sitting in the living room and I was talking about the four sacred plants, tobacco, sage, cedar, and sweet grass. I was trying to get my kids to say "asemaa" and they both would say "say ma," then they would giggle.

I remember my Aunty Karen shared a story about our cousin Jig Strong. He was able to remain a fluent speaker by asking himself a question in the anishinaabemowin and he would answer himself in the anishinaabemowin. I thought that was so awesome! I know it's hard to learn the language. This is my personal belief, one of the reasons why it's hard to learn the language is that our way of learning has changed. I will continue to learn the language as best as I can and pass on what I know to my kids.

On a personal note, I missed putting an article in the May 2021 *Bois Forte News* edition. I would like to wish all the wonderful mothers, grandmothers, great-grandmothers, step-mothers, and aunties a late "Happy Mother's Day." Thank you



for everything that you do and the sacrifices that you made. On a similar note, I would like to wish all the awesome Fathers, Grandfathers, Great-Grandfathers, Step-fathers, and uncles a "Happy Father's Day." Thank you for everything that you do and the sacrifices that you made.

In closing, I need to point out that I am not speaking for the tribal council, I am just sharing what I have done and sharing from my own personal experience. ## Bois Forte Housing has room on waiting list

The Bois Forte Housing Department would like to let band members know that we have room on the waiting list. Our maintenance crew is working diligently on getting homes ready to rent. Currently, we have one, three-bedroom unit available at our Cedar Grove location in Vermilion. Some of the qualify factors are, if your family is under the 80% of median family income for the USA, (please see the chart below for income levels) and you do not owe any monies to any Bois Forte entity.

The application must be complete with necessary documentation before it can be added to the wait list. In the next few months there will be approximately three more 3-bedroom units ready to rent. Two of these are Tax Credit homes in Nett Lake. To be eligible your family must be at/or under 60% of median area income (see the chart below for income levels). If, you qualify to rent this unit you will also qualify to potentially purchase this home. The other 3-bedroom will be available at Cedar Grove in Vermilion if your family is under the 80% of median family income for the USA, (please see the chart below for income levels). There will also be a two-bedroom available in July at the Bois Forte Homes III location in Vermilion.

When you rent one of our homes you will be responsible for paying the utilities, which are the water & sewer, trash, electricity, propane, and any internet/phone service that you choose. For more information, please reach out to the Admissions and Occupancy

#### Emergency Rental Assistance (ERA) Program

The Bois Forte Reservation is excited to offer the Emergency Rental Assistance (ERA) Program which can assist families and individuals who have been negatively impacted by the COVID-19 Pandemic in one way or another.

#### Here are some of the guidelines:

\*You or a member of your household must be an enrolled member of the Bois Forte Band of Chippewa which can include a minor in your care.

- Renting is a requirement of the program.
- Report income for all adults in your household which must be under 80% of median income for the state in which you reside.
- If you qualified for unemployment in the last 90 days, you are automatically qualify for assistance with your rent and utilities.

#### To apply, you do need to have this information:

 Your landlord's name, address, and contact information - We will need to contact your landlord to send payment and confirm that you have a rental agreement.

• We will also need to obtain a W-9 form from your landlord.

• You will need a copy of your lease or rental agreement. If, you are not on a lease, a document from your landlord or the property owner showing the amount you pay and/or the amount you owe for rent.

• A past-due amount/ledger. If, you are behind on your rent, try to get a ledger or a statement from your landlord showing how much and for which months you still owe for rent.

Please be aware that this program is available for renters until December 31, 2021 or funds are no longer available. We can pay arrears as far back as March 13, 2020, there is a limit to the number of months this program can help you.

This program is part of the Rescue America Plan and is provided for by the United States Treasury Department. That is the federal program that oversees the Internal Revenue Service and that means we are required to provide a bit more documentation. This is a federally funded program. You will be required to swear that you do have a qualifying need for the assistance.

You must provide proof of income. You can provide 2020 taxable income information such as (1040s, 1099s, or W2s) these forms must show that they are for the tax year of 2020. Or you may provide pay stubs or other payment information. A form of identification for the head of household. We need a state-issued ID or, Tribal ID card.

You may also be eligible for assistance in paying your utility bills (tenant-paid gas, propane, electric, heat, energy, water or sewer, or internet service. You can apply online and/or via your smart phone.

### HELPFUL TIPS TO REMEMBER ABOUT THE UPCOMING PER CAPITA

- Per Capita payments are issued to all eligible Band Members enrolled as of March 31<sup>st</sup> of that year. New enrollees after March 31<sup>st</sup> will not be eligible for that year's payment. They will begin accruing or receiving per capita payments the following year.
- Information requests by any 3<sup>rd</sup> party pertaining to enrollment information or per capita disbursement will be denied by the Enrollment Coordinator unless accompanied by a Release of Information that is signed and dated by the Band Member.
- There is no early disbursal and all check with addresses shall be mailed. NO EXCEPTIONS.
- If there is not a current address on file, the per capita check will be held by the Enrollment Coordinator or the Accounting Department. These checks are available for pickup starting the first business day after per capita disbursement.
- If the eligible Band Member per capita payment is returned, he/she can retrieve their check in person at the Tribal Government Building. The eligible Band Member will be required to show identification to receive their check.
- If the eligible Band Members per capita payment is returned, the Band Member may choose to have someone else retrieve their check, the individual retrieving the check must have identification and a notarized written statement signed by the eligible Band Member.
- Eligible Band Members must wait a *minimum* of 30 days before any stop payments can be requested and checks be reissued.



## Keep food sources away from bears and other critters

Please help out our friendly Conservation Officers by not leaving out garbage as bears are out and about looking for food.

Most recently, there have been reports of an Adult Female with a cub seen on Tibbetts Trail on the Lake Vermilion Sector getting into garbage.

These bears have been seen in the areas of Whiskey Point, Sovereign Drive, Tibbetts, and Baseball field on the snowmobile trail.

Conservation Officers are asking for the public's help to keep all garbage, bird feeders, dog/cat food inside until further notice. Keep garbage indoors overnight until the morning of curbside pickup, Thursday morning.

Please use caution and be aware of your surroundings when walking/biking on the walking path.

When we take away all easy food sources such as listed above the bear will have no reason to stay in the area of Vermilion and venture out somewhere else.

TIPS- what to do when you come across or are approached by a bear-

- · Do NOT run. Instead, walk backward keeping sight of the bear.
- · Make noise. To scare a bear away make loud noises and make yourself big. If you are with others, stand close together and continue to do this.
- · Dogs. Barking dogs are good bear deterrents also lets you know if one is close.
