Make plans to attend the 2025 State of the Band! Event will take place Saturday, January 18th at Fortune Bay

TOWER— In the hopes of increasing attendance at the Bois Forte Band of Chippewa's State of the Band (SOTB), the 2025 event will take place on a weekend for the first time ever.

"We had heard that holding it on a weekday did not allow band members living out of the area to attend this important event, so we decided to try it on a Saturday instead," said Bois Forte Tribal Chair Cathy Chavers. "Yes, they could tune in to the broadcast remotely, but it didn't give them a chance to experience what this event is all about."

While Chavers said the goal of the SOTB is to keep band members informed, there is also a secondary goal, which is to afford the opportunity for band members to get together to rekindle friendships and make new connections.

"This is one of the biggest social events of the year, and we're hopeful band members will take the time to come out and hear about all the exciting things going on for the Bois Forte Band of Chippewa," said Chavers.

The 2025 SOTB will take place on Saturday, January 18th,

at Fortune Bay Resort Casino. The Woodlands Ballroom will host the dinner and program, while the pre-function area, resort lobby, and executive boardroom will handle informational booths, registration, and an overview of Bois Forte's financial picture, respectively.

Traditionally, all of Bois Forte's programs have an informational booth set up to let band members know more about what services are available. However, other agencies have also set up booths to let band members know about their programs as well.

The day also offers a chance for Bois Forte band members to renew their Tribal IDs, 1854 Treaty Authority IDs as well as to get a flu shot and/or a Covid booster. They can also get an application for any job opening at Bois Forte Tribal Government, Fortune Bay, and other Bois Forte Development Corporation businesses like the Y Store, C Store, and The Wilderness at Fortune Bay.

Boozhoo

I would like to wish everyone a Happy New Year!!!! I know from a tribal government side it is not known if it will be a good year or not for tribes with the new federal administration and new President coming into office. The uncertainty with any change in leadership is weighing on everyone's minds.

Currently we do not know if there will be funding cuts, removal of former Executive Orders, etc. that were in place is a possibility. The sky is the limit I guess you could say. All we can do is wait and see what transpires.

I do know that at our last Tribal Executive Committee (TEC) meeting held on December 12, 2024, in Hinckley, that the Leech Lake band presented a resolution to the TEC to use Red Lake Chippewa Blood in their enrollment criteria.

In the MCT Constitution the term used is "Minnesota Chippewa Indian Blood" and is not specific to the Minnesota Chippewa Tribe Indian blood. Therefore, due to that interpretation, Leech Lake, along with the White Earth Band, have passed their own tribal resolutions to accept Red Lake blood for the enrollment criteria. These resolutions cannot be acted upon until the entire TEC can talk with their tribal members about this change.

The next TEC meeting will be the end of January 2025 in Fond du Lac where there will be a vote taken to decide whether to include Red Lake Chippewa Blood and for the tribes to have an opt in and opt out clause so if some tribes choose to add it others can choose not to. We would like to get our band members' input so please watch for any updates regarding enrollment. Red Lake has made two changes to their enrollment by going back in their rolls and making everyone a full blood. For everybody's information, the blood quantum that was prior to them making everyone a full blood will be what is considered for enrollment with the other MCT blood if approved. Will that make a significant or minor change at Bois Forte? I do not know at this time.

Arrest made in hit and run that claimed life of Amanda Boshey

TOWER— A 50-year-old Virginia man has been arrested in the hit and run death of Amanda Boshey that occurred Tuesday, December 17th.

Boshey, 38, a Bois Forte band member, was walking along Reservation Road near Tibbetts Trail when she was struck and killed.

Tibbetts Trail is roughly a quarter of a mile before the turn into Fortune Bay Resort Casino. Boshey lived on Farm Road, which is roughly one mile east of Fortune Bay Resort Casino.

While details of the incident have been tightly sealed, law enforcement officials had enough cause to arrest Eric Peterson, who allegedly fled the scene after striking Boshey shortly after 9 p.m. Tuesday, December 17th.

Social media was buzzing as family and friends of Boshey demanded answers in the tragic accident. While his alleged involvement was not confirmed by authorities at the time of the Facebook posts, Peterson's Facebook profile being shared online urged authorities to investigate him.

Because the accident took place on the Vermilion Reservation, the FBI is heading up the case. While they did not release Peterson's name, they did issue a brief statement saying that tips from the public were no longer needed in the afternoon hours of Thursday, December 19th.

It was later reported that Peterson was booked into custody at 3:55 p.m. Friday, December 20th by U.S. Marshals Service. As of press time, he is currently in

Douglas County Jail in Superior as he fled to Wisconsin after the accident.

According to University of St. Thomas Law Professor Reid Lebeau, because Peterson is a non-native and the accident took place on an Indian Reservation, he would most likely be prosecuted in federal court in Duluth, Minnesota.

It is also too early to predict what charges Peterson would be facing as many variables, including any past offenses and if he was under the influence when the accident took place, have not yet been disclosed.

Lebeau added that although no punishment can replace what the Boshey family lost, Peterson could be looking at criminal vehicular homicide or criminal vehicular manslaughter, both of which carries a maximum prison sentence of 10 years and a maximum fine of \$20,000.

Boshey was working as a laborer for Whitebird Services out of Local 1091. Her hobbies included shopping, going out to do things with family, and being involved with her recovery community.

According to family members, Amanda was a Leo and always made it a point to let people know that. She always loved lions because of it. Boshey always had something goofy to say, no matter her situation.

Her five kids were her pride and joy even when they weren't living with her. Her smile was contagious, and her laugh was as well. Shopping was her getaway —she always wanted to buy something for her family and friends even when they didn't ask for it. She was always there for family and always


had some way to help.

Boshey was recovering from her harsh addiction and was doing better for herself and her kids.

She would have been three years sober in January; it was something she had always cherished.

Family said that her five kids meant the world to her. Her oldest daugh-

ter was her best friend and was attached at the hip. They always did everything together. She was always active and ready to "Go, go, go," with boundless energy and a zest for life. Boshey hated just sitting around doing nothing. She always had a project in the works and still had

many more ideas she wanted to pursue.

Her friends, family and even strangers, posted heartfelt messages on social media as news spread of the awful tragedy that struck the Boshey family right before the holidays.

A fund has been set up at the Embarrass Vermilion Credit Union (www.evfcu.org) to help Boshey's five children with their financial needs.

Workshops at the Bois Forte Heritage Center & Cultural Museum have been a blast!

Workshops at the Bois Forte Heritage Center & Cultural Museum have been a blast!

On Tuesday, November 12th, the Center hosted a Dreamcatcher Workshop with Theresa Morrison as the main instructor.

Before the class, Jess Anderson, the museum's Language & Cultural Coordinator, had harvested red willow branches, which is what is commonly used to make the dreamcatcher frame. Theresa shared step by step instructions on how to wrap the red willow around itself to make a circle while taking off excess stems from the main branch. Excess pieces can later be used to make smaller dreamcatchers.

Next, each participant was given sinew, a thread made of animal tissue, to make the web inside the red willow circle. Participants were told to tie the sinew right to the frame, then to move it over to another part of the frame with a lock stitch knot until the whole circle was completed. From there, they lock stitched the sinew around the first round that was made, all the way to the center.

On Thursday, November 21st, participants gathered for a Beadwork Workshop where persons could bring projects they were already working on or come in as beginning learners to start a new project with class instructor Theresa Morrison.



In its heyday, even when it was held on a weekday, the annual State of the Band swelled to over 700 attendees. In fact, the program had to be simulcast to the former Multi Purposes rooms on the casino side or the gymnasium at the Vermilion Center. Numbers have since declined to under 400, and it is the hope of Chavers, and the rest of the tribal council that holding the 2025 SOTB on a Saturday will reverse that trend and then continue to grow in the years ahead.

The itinerary for this year's event includes registration/informational booths in the resort lobby and pre-function area from 11 a.m. to 2 p.m. A special financial presentation begins at 1 p.m. in the Executive Boardroom. A Bois Forte Tribal ID is required to gain access to the presentation.


The formal program will begin at 2:30 p.m. in The Woodlands Ballroom,

followed by dinner. The event will wrap up by 5 p.m.

For those not familiar with the SOTB, the program typically includes video presentations from politicians talking about the work they are doing on behalf of the Bois Forte Tribe.


Members of the tribal council are also given a chance to address the attendees, while Chavers then gives the keynote speech that typically gives a comprehensive overview of what Bois Forte as a whole has accomplished during the past year and how things are shaping up for the future.

"We really hope band members show up in record numbers for the 2025 State of the Band," said Chavers. "It is more than just an event—it gives band members a chance to reconnect with their community and to keep them informed as to what is going on with the Bois Forte Band of Chippewa."


