Cathy states that Travis Vake will be leaving Bois Forte employment effective Aug. 1st. Council has entered into a contract with Travis to oversee the Clubs as CEO. As far as any other information we do not have that information right now.

Shane asks about Travis Vakes position. Cathy states that this position will become the new 477 Director position and there will no longer be an Education Director. 477 is new program that we
