Moved by Robert Moyer, Jr.; seconded by Tara Geshick; to censure District I Representative, Perry Drift, for his actions that occurred on April 11<sup>th</sup> and 12<sup>th</sup> at Fortune Bay Resort Casino, which included damage to property, abuse of power and authority and making serious threats to Bois Forte Band Members and guests through jesters and statements all of which has eroded public trust in the Tribal Council, damaged the reputation of the Tribal Council and the Bois Forte Band. Undermined the tribal traditions and values and inflicted fear among guests and staff of Fortune Bay. The censure shall be posted in public places on Bois Forte Reservation and on the Tribal government's official social media outlets. Carried 2-1-0, Perry Drift opposed.
