### PERFORMANCE EXPECTATIONS

In performance of their respective tasks and duties all employees of Bois Forte Band of Chippewa are expected to conform to the following:

- Uphold all principles of confidentiality to the fullest extent.
- Adhere to all professional and ethical behavior standards of the tribal government (may also be referred to as “Band”).
- Interact in an honest, trustworthy, and respectful manner with employees, community, visitors, and vendors.
- Comply with Bois Forte Band of Chippewa policies and procedures.
- Maintain a current insurable driver’s license.
- Display respect and understanding of Bois Forte Band of Chippewa traditions and values.

### POSITION PURPOSE

The Coordinator shall be responsible for the oversight and management of multiple awards related to the Tribes stimulus funds. The Coordinator will be directly responsible for the management of fund for the US Treasury allocation but may include other funding sources as funds are allocated. This individual will work and report under the supervision of the Tribe’s CFO.

### ESSENTIAL DUTIES, FUNCTIONS, & RESPONSIBILITIES

1. Coordinate possible projects submitted for consideration and evaluate with Tribal Council and Tribal Attorney for approval of projects to be completed.
2. Monthly internal reporting and budget monitoring, while adhering to funding guidelines.
3. Reporting to US Treasury for funds received.
4. Responsible for monitoring and ensuring contract/grant/fiscal compliance and performance by coordinating with various tribal department/program staff, tribal entities, and community groups associated with grant rewards.
5. Award close-out procedures.
6. Ensure available funding resources are properly managed, utilized and reported.

7. Provide assistance to tribe for tribal needs and perform special projects.
8. Monitor the financial status of grant funds to ensure requirements are met and achieved.
9. Verify grant expenditures are properly accounted for and utilized in accordance with prescribed terms and conditions.
10. Prepare and file quarterly grant reports.
11. Perform general accounting functions in relation to grants as required or dictated.
12. Coordinate mailings and/or approved by the council from the funding.
13. Ensure all projects follow funding procurement and contracting requirements.
14. Meet biweekly with Tribal Council, Executive Director and CFO, to provide project status updates and financial reports.
15. Work closely with the Tribal Attorney to ensure proper resolutions and documentation is in place for projects.
16. Work closely with the Chief Financial Officer, Executive Director, and Grants Manager to monitor contract/grant performance.

### PREFERRED QUALIFICATIONS

- Knowledge of grant management best practices is preferred.
- Knowledge of relevant tribal, state, and federal law is preferred.
- Knowledge of procurement and construction contract requirements are preferred.

## Position Description

### WORK ENVIRONMENT

- Work environment:** The work environment characteristics described here are representative to those an employee encounters while performing the primary functions of this job. Normal office conditions exist, and the noise level in the work environment can vary from low to moderate. Limited overnight travel may be required from time to time.
- Physical demands:** The physical demands described here are representative of those that must be met by an employee to successfully perform the primary functions of this job. While performing the duties of this job, the employee may be required to frequently stand, walk, sit, bend, twist, talk, hear, and perform repetitive motions. - Mental demands:** There are several deadlines associated with this position. The employee must be able to handle frequent interruptions and must also multi-task and interact with a wider variety of people on various and, at times, complicated issues.

### TRIBAL AND INDIAN PREFERENCE

The Bois Forte Band of Chippewa has implemented a Tribal and Indian Preference in Employment Policy. Pursuant to this Policy, applicants who possess the knowledge, skills, and abilities required by this position, and who are enrolled members of the Bois Forte Band of Chippewa Tribe will be given primary preference in hiring and employment for this position. Members of other federally recognized Indian tribes will be given secondary preference for hiring and employment after providing proof of tribal membership. Tribal and Indian preference is integrated into the interview and scoring process for candidates for job positions.

### OTHER

- Confidentiality:** All employees must uphold all principles of confidentiality to the fullest extent. This position may have access to sensitive information and a breach of these principles will be grounds for immediate termination.
- Background Investigation:** This position may be subject to a criminal history background check, a suitability background check and/or a fair credit reporting act (FCRA) check. In addition, some positions are subject to a 101-630 background check in an effort to ensure compliance with public law 101-630 "Indian Child Protection and Family Violence Prevention Act." Candidates must be able to successfully pass all required background checks to qualify for this position.
- Drug Screening:** All applicants must successfully pass a pre-employment drug screening prior to beginning employment and will be subject to random drug testing.
