### PERFORMANCE EXPECTATIONS

In performance of their respective tasks and duties all employees of Bois Forte Band of Chippewa are expected to conform to the following:

- Uphold all principles of confidentiality to the fullest extent.
- Adhere to all professional and ethical behavior standards of the tribal government (may also be referred to as "Band").
- Interact in an honest, trustworthy, and respectful manner with employees, community, visitors, and vendors.
- Comply with Bois Forte Band of Chippewa policies and procedures.
- Display respect and understanding of Bois Forte Band of Chippewa traditions and values.

### POSITION PURPOSE

The Head Start/Early Head Start Teacher Aide Substitute is responsible for assisting the Head Start and Early Head Start Teachers as a substitute teacher. Responsibilities of this position include carrying out the classroom activities and component plans currently in place, and providing support through classroom and playground supervision of all children. Must work closely with parents and families to support and meet the needs of the children in the classroom.

### ESSENTIAL DUTIES, FUNCTIONS, & RESPONSIBILITIES

1. Provide a safe environment to prevent and reduce injuries.
2. Promote good health and nutrition.
3. Provide materials and resources for children by constructing an interesting and enjoyable environment that encourages exploration and learning.
4. Assist Head Start and Early Head Start teachers in all aspects of planning and implementing the Head Start and Early Head Start Programs for children, including, indoor and outdoor play and learning activities, mealtimes, and nap/rest times.
5. Assist in the implementation of curriculum and measurement of outcomes with the Teaching Strategies GOLD online reporting system.
6. Help create and maintain an interesting and orderly physical environment conducive to optimal growth and development of children.
7. Help create an accepting and nurturing atmosphere for children.

8. Work as part of the Head Start and Early Head Start Center team.
9. Assure and document two-way communication between Center and parents, staff and supervisors.
10. Assist children in learning skills necessary to negotiate, problem solve, care for themselves, be responsible for materials, and work through difficulties in an age appropriate manner.
11. Attend required staff meetings and planning sessions. Attend training pertinent to job duties, according to staff development plan. Must keep CPR and First Aid up-to-date. Must have a complete physical including TB test upon hire, and annually thereafter.
12. Actively participate in floor activities with children.
13. Complete required forms, records and contracts.
14. Maintain and document communication with parents.
15. Rotate bus aide duties.
16. Promote children's learning by openly communicating and interacting with them on the bus.
17. Must maintain confidentiality and adhere to the Bois Forte and Program Code of Ethics.
18. Perform other duties as required by program regulations, policies or procedures, or as assigned by supervisor.

## Position Description

### WORK ENVIRONMENT

- Work environment:** The work environment characteristics described here are representative of those an employee encounters while performing the primary functions of this job. Normal office conditions exist, and the noise level in the work environment can vary from low to moderate. Limited overnight travel may be required from time to time.
- Physical demands:** The physical demands described here are representative of those that must be met by an employee to successfully perform the primary functions of this job. While performing the duties of this job, the employee may be required to frequently stand, walk, sit, bend, twist, talk, hear and perform repetitive motions. There may be prolonged periods of sitting, keyboarding, reading, as well as driving or riding in transport vehicles. The employee must occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include reading, distance, computer, and color vision. Talking and hearing are essential to communicate with the community, visitors, employees, and vendors.
- Mental demands:** There are a number of deadlines associated with this position. The employee must be able to handle frequent interruptions and must also multi-task and interact with a wider variety of people on various issues.

### TRIBAL AND INDIAN PREFERENCE

The Bois Forte Band of Chippewa has implemented a Tribal and Indian Preference in Employment Policy. Pursuant to this Policy, applicants who possess the knowledge, skills, and abilities required by this position, and who are enrolled members of the Bois Forte Band of Chippewa Tribe will be given primary preference in hiring and employment for this position. Members of other federally-recognized Indian tribes will be given secondary preference for hiring and employment after providing proof of tribal membership. Tribal and Indian preference is integrated into the interview and scoring process for candidates for job positions.

### OTHER

- Confidentiality:** All employees must uphold all principles of confidentiality to the fullest extent. This position may have access to sensitive information and a breach of these principles will be grounds for immediate termination.
- Background Investigation:** This position may be subject to a criminal history background check, a suitability background check and/or a Fair Credit Reporting Act (FCRA) check. In addition, some positions are subject to a 101-630 background check in an effort to ensure compliance with Public Law 101-630 "Indian Child Protection and Family Violence Prevention Act." Candidates must be able to successfully pass all required background checks to qualify for this position.
- Drug Screening:** All applicants must successfully pass a pre-employment drug screening prior to beginning employment and will be subject to random drug testing.
- Vaccine Requirement:** The Bois Forte RTC adopted the COVID-19 Vaccination Requirement (Resolution No. 61-2022) which provides that COVID-19 vaccination is required for all employees of the Bois Forte Tribal Government and Band-owned businesses. That Requirement also applies to newly hired employees who must by their first date of employment either (1) present proof of receiving all COVID-19 vaccinations for which they are eligible under CDC guidance or (2) be approved for a medical or religious exemption from the Vaccine Requirement. If the employee only presents proof of the first dose of a two-dose COVID-19 vaccine by the first date of employment, the employee must further present proof of a second dose within 30 days of the date of the employee's first dose and proof of a booster vaccination within one month of eligibility. If the employee only presents proof of a single-dose COVID-19 vaccination or both doses of a two-dose COVID-19 vaccination by the first date of

employment, the employee must further present proof of a booster vaccination within one month of eligibility.
