PERFORMANCE EXPECTATIONS

In performance of their respective tasks and duties all employees of Bois Forte Band of Chippewa are expected to conform to the following:

- Uphold all principles of confidentiality to the fullest extent.
- Adhere to all professional and ethical behavior standards of the tribal government (may also be referred to as "Band").
- Interact in an honest, trustworthy, and respectful manner with employees, community, visitors, and vendors.
- Comply with Bois Forte Band of Chippewa policies and procedures.
- Maintain a current insurable driver's license.
- Display respect and understanding of Bois Forte Band of Chippewa traditions and values.

POSITION PURPOSE

The Roadways Maintenance Worker/Wastewater Trainee will perform routine skilled work and will operate motorized equipment used in the construction, repair, and maintenance of reservation roadways. The work involves the safe and efficient operation of various pieces of equipment which includes, but is not limited to, tractors, dozers, backhoes, rollers, graders, and pick-up snowplows. Duties also include the minor repair and maintenance of such equipment.

ESSENTIAL DUTIES, FUNCTIONS, & RESPONSIBILITIES

- 1. Operate heavy equipment such as excavators, bulldozers, graders, loaders, skid steers, and other equipment in the construction, repair, and maintenance of roadways.
- 2. Safely perform tasks such as digging, grading, trenching, compacting, and loading/unloading materials.
- 3. Ensure all roadways are clear and passable including snow plowing and sanding.
- 4. Perform routine roadway inspections.
- 5. Clean drainage ditches and culverts. Replace damaged culverts if necessary.
- 6. Fills potholes, seals cracks and repairs eroded areas on road surfaces.
- 7. Remove litter and debris from roadways.
- 8. Cut and remove brush from right of ways.
- 9. Mows the grass from the roadsides.
- 10. Maintain tools, service equipment and make repairs on a regularly scheduled basis.
- 11. Make deliveries of fuels, tires, and parts to job sites.

- 12. Performs traffic control duties, including flagging, on road repair projects, as necessary.
- 13. Follow project plans, blueprints, and specifications to ensure accurate execution of all projects.
- 14. Demonstrate punctual and reliable attendance in accordance with designated work schedule.
- 15. Perform all assigned tasks according to established safety rules, regulations, and practices, and promptly report work-related injuries, unsafe conditions, and near-miss incidents to immediate supervisor.
- 16. Performs surveillance duties if required, for security of property and equipment.
- 17. Perform preventative maintenance and upkeep of shop and equipment.
- 18. Will be required to work before and after regular business hours, on weekends and holidays and during inclement weather.
- 19. Perform repairs on Public Works and other government vehicles and equipment.
- 20. Maintain an accurate record of work performed.
- 21. Assist with burials, as requested.
- 22. Assist in water/sewer repairs and follow duties assigned by wastewater operator in Nett Lake and/or Vermilion.
- 23. As an employee of the Bois Forte Reservation, will follow the Bois Forte Procurement Policy and any other applicable procurement requirements when obtaining goods and/or services for the Bois Forte Band of Chippewa.
- 24. Other job-related duties as assigned by Supervisor.

MINIMUM MANDATORY QUALIFICATIONS

• One year of general knowledge in roadway maintenance or construction.

Experience: Education:

High School Diploma or GED.

License/Certification:

 Must possess a valid Minnesota driver's license and be insurable under the RTC automobile insurance policy and any other motor vehicle use policies applicable to the position. Willing to train toward obtaining a class A or B Commercial driver's license.

Mandatory Knowledge, Skills, Abilities and Other Qualifications:

- Ability to follow oral and written instructions.
- Ability to perform strenuous physical labor under less than desirable conditions.
- Ability to train and work towards Roadways Maintenance/Wastewater operator field.
- Ability to maintain effective working relationships with co-workers and supervisors.
- Ability to learn and operate equipment in a safe manner.
- Knowledge of the methods and materials used in the maintenance of roads.
- Knowledge of basic hand tools (ratches, sockets, crescent wrenches, and wrenches).
- Considerable knowledge of the proper and safe operation of motorized equipment.
- Must be willing to learn the Indian Reservation Road Inventory system and procedures.
- Basic operation of a workstation (turning on/off, knowledge of basic functions and components).
- Ability to perform other duties as assigned.

WORK ENVIRONMENT

Position Description

Work environment: The work environment characteristics described here are representative to those an employee

> encounters while performing the primary functions of this job. The physical environment requires the employee to work both inside and outside in heat/cold, wet/humid, and dry/arid conditions. Limited

overnight travel may be required from time to time.

Physical demands: The physical demands described here are representative of those that must be met by an employee to

> successfully perform the primary functions of this job. While performing the duties of this job, the employee may be required to frequently stand, walk, sit, bend, twist, talk, hear and perform repetitive motions. There may be prolonged periods of sitting, keyboarding, reading, as well as driving or riding in transport vehicles. The employee must occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include reading, distance, computer, and color vision. Talking and hearing

are essential to communicate with the community, visitors, employees and vendors.

Mental demands: There are a number of deadlines associated with this position. The employee must be able to handle

frequent interruptions and must also multi-task and interact with a wider variety of people on various

and, at times, complicated issues.

TRIBAL AND INDIAN PREFERENCE

The Bois Forte Band of Chippewa has implemented a Tribal and Indian Preference in Employment Policy. Pursuant to this Policy, applicants who possess the knowledge, skills, and abilities required by this position, and who are enrolled members of the Bois Forte Band of Chippewa Tribe will be given primary preference in hiring and employment for this position. Members of other federally recognized Indian tribes will be given secondary preference for hiring and employment after providing proof of tribal membership. Tribal and Indian preference is integrated into the interview and scoring process for candidates for job positions.

Confidentiality: All employees must uphold all principles of confidentiality to the fullest extent. This position may

have access to sensitive information and a breach of these principles will be grounds for immediate

termination.
