TRAFFIC WAIVER

PERSONS CHARGED WITH VIOLATING CERTAIN PROVISIONS OF THE BOIS FORTE TRAFFIC CODE MAY AVOID A COURT APPEARANCE BY PAYING THE ESTABLISHED FINE AND ENTERING A PLEA OF GUILTY AND SIGNING THE WAIVER BELOW. (Bois Forte Traffic Code, Section 824, Subd 4).

THIS PROVISION DOES NOT APPLY TO ANY PERSON CHARGED WITH A TRAFFIC OFFENSE FOR WHICH THEY HAVE BEEN PREVIOUSLY CONVICTED BY THE BOIS FORTE TRIBAL COURT WITHIN THE PREVIOUS TWO (2) YEARS.

If you plead guilty by paying a fine before your scheduled hearing, you waive your rights to:

- 1 Trial;
2. Representation by counsel of your choice at your own expense;
3. To be presumed innocent until proven guilty beyond a reasonable doubt;
4. To confront and cross examine all witnesses against you;
5. Either remain silent or to testify on your behalf, and
6. Appeal

I further understand the <i>Waiver is not processed until payment is received at the Court in full.</i>
