PERFORMANCE EXPECTATIONS

In performance of their respective tasks and duties all employees of Bois Forte Band of Chippewa are expected to conform to the following:

- Uphold all principles of confidentiality to the fullest extent.
- Adhere to all professional and ethical behavior standards of the tribal government (may also be referred to as "Band").
- Interact in an honest, trustworthy, and respectful manner with employees, community, visitors, and vendors.
- Comply with Bois Forte Band of Chippewa policies and procedures.
- Maintain a current insurable driver's license.
- Display respect and understanding of Bois Forte Band of Chippewa traditions and values.

POSITION PURPOSE

The Community Health Representative (CHR) is a frontline public health worker and trusted member of the community who provides culturally appropriate health education, patient navigation, outreach, and support services. CHRs serve as a bridge between the Tribal community and healthcare systems, helping individuals and families access resources, manage chronic conditions, and improve overall health outcomes.

ESSENTIAL DUTIES, FUNCTIONS, & RESPONSIBILITIES

1. Provide one-on-one education to individuals on health-related topics through assigned home visits and walk-in visits. Will deliver culturally appropriate health education on wellness, chronic disease management, and prevention.
2. Assist clients in bathing, blood pressure monitoring, blood glucose monitoring, and other duties as assigned by Community Health Nurse or Medical Provider.
3. Coordinate and develop annual, quarterly, and monthly reports for Bois Forte Band of Chippewa Health and Human Services Department.
4. Attend all training, workshops, continuing education, and meetings related to the position.
5. Maintain current, accurate and secure files ensuring they comply with HHS and HIPAA regulations.
6. Provide home visits, outreach, and follow-up care to community members in homes, hospitals, nursing homes, and other facilities.
7. Organize and maintain a current file on all client referrals with pertinent data and social service resources available to the community; maintains referrals and appointments for clients to ensure that appointments have been met.
8. Serve as a liaison between the community and health/social service resources. Collaborate with healthcare providers, Tribal programs, and community partners. Serve as an advocate for patients in navigating healthcare systems.

9. Transport clients to health resources when clients have no other means of transportation in accordance with Bois Forte Human Services Transportation Policy.
10. Maintain arrangements and assist with special clinics during the year, such as immunization, audiology, optometry, and other community clinics as needed. Conduct basic health screenings (e.g. blood pressure and/blood glucose).
11. Conduct home safety assessments for potential hazards and make appropriate contacts to remove hazards.
12. Maintain and organize the Bois Forte Needs Program. Refers community members to the program as needed.
13. Perform clerical duties, including typing and word processing for the Community Health Department Staff.
14. As an employee of the Bois Forte Reservation, will follow the Bois Forte Procurement Policy and any other applicable procurement requirements when obtaining goods and/or services for the Bois Forte Band of Chippewa.
15. Perform other duties as assigned.

WORK ENVIRONMENT

Work environment: The work environment characteristics described here are representative to those an employee encounters while performing the primary functions of this job. Normal office conditions exist, and the noise level in the work environment can vary from low to moderate. Limited overnight travel may be required from time to time. This position may be exposed to certain health risks that are inherent when working within a health center facility, such as potential exposure to hazardous chemicals, sharps, and infectious body fluids.

Physical demands: The physical demands described here are representative of those that must be met by an employee to successfully perform the primary functions of this job. While performing the duties of this job, the employee may be required to frequently stand, walk, sit, bend, twist, talk, hear and perform repetitive motions. There may be prolonged periods of sitting, keyboarding, reading, as well as driving or riding in transport vehicles. The employee must occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include reading, distance, computer, and color vision. Talking and hearing are essential to communicate with the community, visitors, employees, and vendors.

Mental demands: There are a number of deadlines associated with this position. The employee must be able to handle frequent interruptions and must also multi-task and interact with a wider variety of people on various issues.

TRIBAL AND INDIAN PREFERENCE

The Bois Forte Band of Chippewa has implemented a Tribal and Indian Preference in Employment Policy. Pursuant to this Policy, applicants who possess the knowledge, skills, and abilities required by this position, and who are enrolled members of the Bois Forte Band of Chippewa Tribe will be given primary preference in hiring and employment for this position. Members of other federally recognized Indian tribes will be given secondary preference for hiring and employment after providing proof of tribal membership. Tribal and Indian preference is integrated into the interview and scoring process for candidates for job positions.

OTHER

Confidentiality: All employees must uphold all principles of confidentiality to the fullest extent. This position may have access to sensitive information, and a breach of these principles will be grounds for immediate termination.

Background Investigation: This position may be subject to a criminal history background check, a suitability background check and/or a Fair Credit Reporting Act (FCRA) check. In addition, some positions are subject to a 101-630 background check in an effort to ensure compliance with Public Law 101-630 "Indian Child Protection and Family Violence Prevention Act." Candidates must be able to successfully pass all required background checks to qualify for this position.

Drug Screening: All applicants must successfully pass a pre-employment drug screening prior to beginning employment and will be subject to random drug testing.
